JOB THREATENED?

NSEA has 18 field representatives, called UniServ directors. Former teachers, they work directly with you and your local association on all job-related issues. They provide guidance for evaluation concerns; assist in resolving teacher contract disputes; and constantly strive to improve working conditions; among other duties. Got a job-related issue? Get telephone assistance immediately, and when needed, on-site assistance, often within 24 hours.

LEGAL SERVICES

A seemingly harmless action can land you in the administration's office or with a contact from a law enforcement agency. Take comfort knowing that NSEA is ready to assist if you face any sort of job-related sanction. NSEA's 18 UniServ Directors are stationed across the state as the initial defense if you are embroiled in an employment dispute. And only NSEA provides the on-site help of attorneys, if needed.

Every year, your local association negotiates to improve your salary, fringe benefits, extra duty pay schedule and working conditions.
